### A Proposal to Reorganize the MDI Regional School System

The numbers of students are dwindling and 4 different models have been proposed by a special committee to address the elephant in the room. The new structure would create a single district with one board, one budget and one employer for all staff. The goal is to Overhaul the existing system and provide a stronger, better co-ordinated curriculum, better and more efficient special education programs and services, greater access to extra-curricular activities, provide more opportunity for students to form successful peer groups and better grouping for teaching to best meet the student’s needs.
